The law requires completion of Verification before awarding and/or disbursing federal aid. If there are differences between your FAFSA application and your verification documentation, electronic corrections to your FAFSA may be required.

#### **IRS Data Retrieval Tool**

The best way to verify income is by using the <u>IRS Data Retrieval Tool</u> (IRS DRT) while completing the <u>FAFSA</u>. Using this tool is the easiest and most accurate way to complete the application. This tool automatically imports the tax information from the correct year's tax return directly into the FAFSA, which saves time and ensures accuracy! To use the IRS Data Retrieval Tool, you and your spouse/parent's identifying information entered must match exactly what is reported on their tax return. In most cases, no further documentation is needed to verify 2021 income information that was transferred into the student's FAFSA using the IRS DRT if that information was not changed.

### **IRS Tax Return Transcript**

If you are unable to use the IRS DRT, you can obtain a 2021 IRS Tax Return Transcript using one of the following options:

- Get Transcript by Mail Go to <a href="www.irs.gov">www.irs.gov</a>, click "Get Your Tax Record." Click "Get Transcript by Mail." Make sure to request the "Return Transcript" and NOT the "Account Transcript.
- Get Transcript Online Go to <a href="www.irs.gov">www.irs.gov</a>, click "Get Your Tax Record." Click "Get Transcript Online." Make sure to request the "Return Transcript" and NOT the "Account Transcript."
- Automated Telephone Request 1-800-908-9946.
- Paper Request Form IRS Form 4506T-EZ or IRS Form 4506-T.

Transcripts are generally received within 10 business days from the IRS's receipt of your request except for the "Get Transcript Online" option which displays the transcript upon successful completion of the IRS's two-step authentication.
