

2019-2020 Verification Worksheet

Your application has been selected for a review process called "Verification." The law says we have the right to ask you for this information before awarding Federal aid. If there are differences between your application information and your financial documents, you or NAU may need to make corrections electronically or by using your Student Aid Report (SAR).

Complete this verification form and submit it to your financial aid administrator as soon as possible so your financial aid processing will not be delayed.

What you should do

- 1. Collect you and your parent(s)' or spouse's (if you are married) financial documents (IRS Tax Return Transcript, W-2 forms, etc.).
- 2. Talk to your financial aid administrator if you have questions about completing this worksheet.
- 3. Complete and sign the worksheet—you and your parent or spouse as applicable.
- 4. Submit the completed worksheet, tax forms, and any other documents your school requests to your financial aid administrator.
- 5. Your financial aid administrator will compare information on this worksheet and any supporting documents with the information you submitted on your application. NAU may need to make corrections electronically or by using your SAR.
